

# COPYRIGHT, AUTHOR RIGHTS & PERMISSIONS

To enable technology transfer of a high degree, the Australian Centre for Geomechanics (ACG) produces publications including, but not limited to, supporting material for its many events in both hardcopy and electronic format, books, research reports, specialist publications, training DVDs, and an online repository of conference proceedings.

The ACG is committed to publishing high-quality work and as such, there are a number of ACG and author responsibilities and requirements involved in the publication process which are outlined in this document.

## Australian Centre for Geomechanics

### *Copyright*

When an author submits the final version of their work for an ACG publication, the ACG requires that a Copyright Permission Agreement is also signed.

The ACG requests a worldwide, exclusive copyright to publish the work in all mediums and languages including, but not limited to, hardcopy, electronic, internet, and CD/DVD formats. This includes the work being available for open access on the [ACG Online Repository of Conference Proceedings](#), and any other future publication that the ACG may undertake. This is to ensure that the ACG holds the distribution rights of the work that it publishes, as well as the rights associated with such.

By signing the Copyright Permission Agreement, the author acknowledges that they are the sole owner of all copyrights in the work, that they are able to transfer their rights, and that the work does not infringe anyone else's copyright.

### *Permission for republication or other use*

**By primary author:** If you are the primary author of work published in an ACG publication and you request that the ACG grants permission for you to republish it elsewhere, permission may be granted on a case-by-case basis. All requests for permission for republication or other use by authors should be made to the ACG publications team at [publications-acg@uwa.edu.au](mailto:publications-acg@uwa.edu.au) and include the following information:

- Title of work;
- Name of author/s;
- Title of publication or event that the work was first published; and
- Republishing information including title of publication, name of publisher, and whether work will be published in original or modified form.

Authors are generally not permitted to publish the final published version of the work prepared by the ACG in any capacity, including on a personal or business website, as the ACG holds the exclusive website rights of final published papers. However, authors are welcome to contact the ACG should they wish to do so as this is decided on a case-by-case basis.

**By non-primary-author:** If the ACG receives a request to use content published in an ACG publication by someone who is not the primary author, the ACG will grant permission on the condition that the source is acknowledged through correct

citation and referencing. Republication of a work or portions thereof (e.g. extensive excerpts, figures, tables, etc.) in original form or in translation, as well as other types of reuse (e.g. in course/training packages) requires formal permission from the ACG and may be subject to royalty fees. As a courtesy, the author of the original work should be informed by the non-primary-author of any request for republication/reuse.

All requests for permission for republication or other use by non-authors should be made to the ACG publications team at [publications-acg@uwa.edu.au](mailto:publications-acg@uwa.edu.au) and include the following information:

- Title of work;
- Name of author/s;
- Title of publication or event that the work was first published;
- Republishing information including title of publication, name of publisher, and whether work will be published in original or modified form;
- Format (hardcopy and/or electronic);
- Number of copies to be distributed; and
- Date of publication.

#### ***Content owned by entity or body other than the primary author***

If the author's employer, the Crown, or any other entity or body owns all or part of the work, the Copyright Permission Agreement can be amended to reflect such. Alternatively, the co-owner may provide the ACG with official correspondence stating the terms of copyright, in lieu of the ACG Copyright Permission Agreement. ## **Authors**

#### ***Plagiarism and copyright***

Authors must ensure that they appropriately cite the work of anyone else that they refer to in their work. Plagiarism includes copying or paraphrasing the work of others, making the work of others appear to be your own, and publishing tables and figures created by someone else.

Plagiarism is not acceptable or ethical publishing behaviour. Where it is determined by the ACG editorial team that the work contains plagiarised content, the work will not be accepted for publication.

Any information obtained through personal or private communications with third parties should not be included without permission from the third party. Such communications should be cited within the work.

#### ***Duplicate submissions***

Authors must not submit for publication any work which has already been published in, or is being considered for inclusion in, any other publication. This extends to work covering essentially the same research or results and work that contains substantially similar tables, figures, or passages of text.

The ACG may allow duplicate submission in certain circumstances. Copyright permission from the original publisher of the work must be obtained in writing.

#### ***Peer-review process***

In order to be considered for publication, authors must participate in the peer-review process. Any reviewer comments, suggestions, or requests for amendments must be made in a timely manner. Any amendments must be made to the satisfaction of the reviewers and the editor, and amendments will be checked by the ACG publications team. When an author does not wish to make an amendment requested by a reviewer, they must specify their reason/s why.

### ***Authorship***

Anyone listed as an author of the work must meet at least one of the following criteria:

- Have made a significant contribution to the writing of the work or have revised it; or
- Have made a significant contribution to the conception, design, execution, or analysis of the study or work in question.

All authors must have read and approved the final version of the work and agreed to its submission for publication. It is the responsibility of the corresponding author to ensure this.

### ***Significant errors in work***

It is the responsibility of the authors to ensure that their manuscripts are as accurate and error-free as possible. If an author discovers that their work contains a significant error, they must promptly notify the ACG and work with the ACG to correct the error, retract the work, or issue an erratum.

### ***Conflicts of interest***

Authors must, as early as possible, advise the editor of any conflict of interest which could be construed to influence or affect the goal, results, or interpretation of the work. A conflict of interest may include any commercial, personal, or professional relationship with the product, service, or research that is the topic of the work. A conflict of interest may also include any relationship to the companies or organisations connected to the work and its contents.
